- Big Bend Now article titled "Marfa ISD, county approve tax abatements for solar projects" written by John Daniel Garcia and published on April 24, 2014
- State Auditor's Office SAO Report No. 15-009, released November 2014 -An Audit Report on Selected Major Agreements Under the Texas Economic Development Act
- Dallas News article titled "Audit criticizes Texas economic development program run by school districts" written by Robert Garrett and published on November 20, 2014;
- The Texas Tribune article titled "Audit: Little Oversight for School District Tax Breaks", written by Aman Batheja and published on November 21, 2014.

In conclusion Mr. Garabedian pointed out the following:

- This issue will continue as evidenced by recent events (email, recent presentations to government bodies by Pristine Sun Solar, LLC)
- The Chapter 313 process is problematic
- The Auditor for the State of Texas has recently published SAO Report No. 15-009
- the Board and Cabinet should read the report
- For me there is a philosophical, perhaps a moral question, of fairness

Mr. Roberto Chavira stated this item needs to be looked at in further detail and HB 3390 will be introduced to extend the abatement process for an additional 10 years, but this has to be a House Bill and a Senate Bill so this may not come into fruition. Mr. Chavira also stated that after the submittal is done, the comptroller's office will perform an impact study and provide recommendations, the district would then act accordingly from the results of the study. Mr. Chavira further stated he is not for this or against this item at this time, only that it should be looked at further.

Mr. Joshua Overfelt made the motion for a 5 minute recess at 8:35 p.m.
